## **Frequentis AG: Dividend proposal of EUR 0.20 per share for financial year 2021**

Vienna (pta051/07.03.2022/20:20) - The Executive Board of Frequentis AG has decided - subject to the approval of the Supervisory Board - to propose a dividend of EUR 0.20 per share, totalling EUR 2.656 thousand, (previous year: EUR 0.15 per share) for the 2021 financial year to the Annual General Meeting for resolution.

The shares of Frequentis AG are traded on the Vienna and Frankfurt Stock Exchange under the ticker symbol FQT (ISIN: ATFREQUENT09). According to the preliminary figures for the year 2021, a turnover of more than EUR 330 million and an EBIT of around EUR 28 million were generated. Following the transaction with L3Harris, the number of employees is around 2,100.
